Plot 122 – as shown

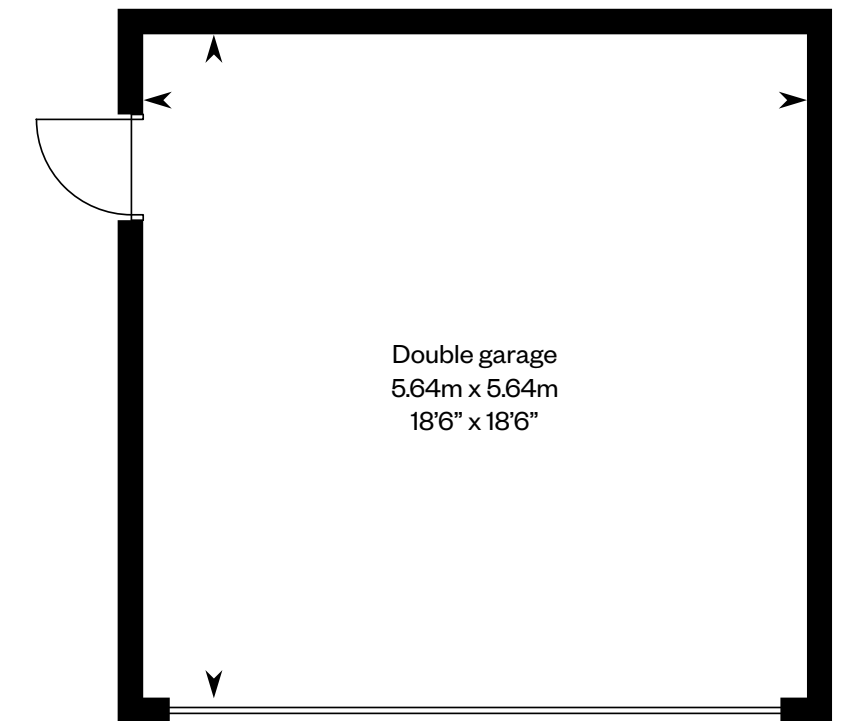
